Sub: Proceedings of the Committee on Fixation of Fee Structure in respect of Teacher Education in Self-Financing Colleges – Revision of fees for 2-year B.Ed and M.Ed Degree Programmes and Fixation of Fees for 4-year Integrated B.Sc B.Ed and B.A B.Ed Degree Programmes - Reg.

Ref: Proc.No.CFF/472/Teacher Education/Fees/2016, dated 29.08.2016.

I am by direction to state that in the proceedings of the Committee on Fixation of Fee Structure in respect of Teacher Education in Self-Financing Colleges under the Chairmanship of Hon'ble Mr.Justice N.V.Balasubramanian, the Fee Structure has been prescribed as follows:

The maximum fee per student per annum for Self-Financing Colleges of Education for B.Ed., M.Ed., B.Sc B.Ed., B.A B.Ed Degree Programmes, inter-alia, is as follows:

Sl.No.	Name of the Programmes	Fee fixed by the Committee in Rs. per annum per student
1.	B.Ed ✓	Rs.37,500/- ✓
2.	M.Ed	Rs.38,000/-
3.	B.Sc B.Ed (4-year Integrated)	Rs.25,000/-
4.	B.A B.Ed (4-year Integrated)	Rs.22,500/-

The fees structure prescribed above will take effect from the academic year 2016-2017 and will be valid for three academic years upto 2016-2017, 2017-2018 and 2018-2019.

The above fee is inclusive of Admission fee, Tuition fee, University Registration and Eligibility fee, Library and Magazines Fee, Laboratory Fee, Sports fee, Games fee (equipments for Physical Education courses) and Extra Curricular Activities Fee, Medical Check-up Fee, Teaching Practice Fee, Maintenance and Amenities Fee and Development Fee. It is classified that the above fee fixed is the maximum fee under the above various heads and the institutions shall not collect and levy more fee than the fee fixed by the Committee.

Any deviation of the order of this Committee will entail serious penal consequences like withdrawal of approval by NCTE and disaffiliation by the concerned University as well as imposition of fine.

Any student/parent aggrieved by overcharging of fees, if any by the institutions is at liberty to approach the Committee/University for redressal.

The Chairmen/Secretaries/Principals of all the Colleges of Education affiliated to this University are strictly instructed to collect the fees from students as prescribed by the Fee Fixation Committee.

The fee structure fixed by the Committee should be displayed on the college Noticeboard to make the fee structure transparent to all students in your college.
